Top Tips: Medicine Records

A complete purchase and treatment record must be kept for all veterinary medicines administered to livestock. This enables the monitoring of all livestock treatments and a retrospective review of routine procedures and to identify recurring problems.

MEMBERSHIP PAYMENTS

Annual Health and Welfare Reviews

Since the 1st of July 2018 a new requirement of the FAWL standard is that an annual health and welfare review must be undertaken in conjunction with your farm vet. To date in the region of 3500 of these reviews have been completed.

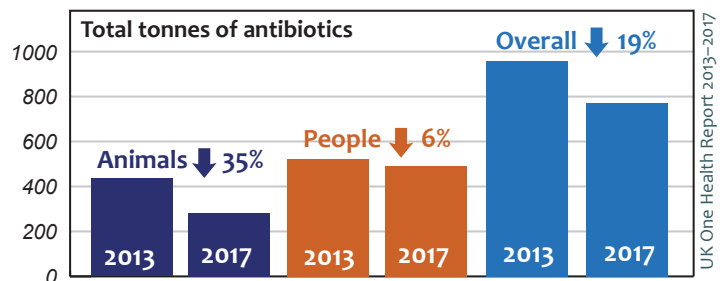
The review gives an opportunity to address any issues that have occurred on the farm in the last 12 months and particularly focuses on the use of antibiotics and anthelmintic products on the farm.

Of the initial reviews that have been undertaken by vets it's clear to see that the aspect that has had most attention, discussion and recommendations have been around the correct use of sheep anthelmintic (drenches) treatments.

Early indications seem to demonstrate that the use of antibiotics at the right time is also an area to improve on as well as improving biosecurity and considering the greater use of vaccinations where appropriate.

Below are some figures that were recently published from an executive summary of the UK One health report 2013–2017 on antibiotic use in animals and humans (published January 2019). Please note that by working proactively with your vet in ensuring that your use of antibiotics is responsible on your farm that you are contributing to the reduction in usage and therefore prompting a positive message which this report demonstrates.

WLBP Farm Records facility providing great advantages



Jolyon Higgs and his wife Alex of Cwmfron Farm, Tylwch, run a beef and sheep enterprise on their farm in the uplands of Llanidloes which ranges from 650–1000ft.

600 breeding ewes are kept at Cwmfron Farm consisting of Welsh Mules, Welsh Mountain and Texel. Jolyon and Alex also keep a herd of 20 suckler cows which are Limousin and British Blue cows producing Aberdeen Angus cross prime cattle.

50–60 Welsh Mules are retained on the farm with another 50 yearling ewes being sold through the Welsh Mules Sheep Breeders Association Sales every year at Welshpool Livestock Market.

As members of the Farm Assured Welsh Livestock (FAWL) scheme, Jolyon and Alex have taken advantage of the online WLBP Farm Records facility available to them free as part of their subscription. After registering and creating an account, their FAWL and cross compliance documentation are populated and kept online. This includes their flock book, herd register and medicine book. Jolyon says:

'I first heard of the facility when I went to a Waitrose producer meeting. It prompted the idea that I could reduce paperwork and maintain more accurate online records. With increasing demands from retailers and government to keep records I felt it was beneficial to have all of the records in one place.'

There is also a mobile phone app that works alongside the WLBP Farm Records website; The Stock Move Express app allows users to input information offline while on the farm.

'I mainly use the Stock Move Express app, I can input information standing by the animal. As I always have the program available to me, I can look up information such as treatments, withdrawal dates and movement history all from my phone.'

Jolyon uses the facility to record movements which can be linked to EID Cymru and BCMS. He also records medicine purchases, treatments, individual ewe records and registering births and deaths.

'By recording the medicine treatment of my animals, I can build up a history of individual ewes. It helps me manage my flock better as I can select animals that are prone to regular occurring diseases. With the link to EID Cymru I can store all my movement licenses in one place and they can be sent direct to them.'



Jolyon is seeing advantages in utilising his online Farm Records tools and looks forward to expanding his usage of the facility which will contribute towards keeping all records up to date on the farm.

£5m to help eradicate sheep scab

The Minister for Environment, Energy and Rural Affairs, Lesley Griffiths, has announced £5m available through the Rural Development Programme will be used to help eradicate sheep scab.

The funding is available to deliver an industry led project to tackle the disease in Wales. The announcement follows an industry proposal to eradicate sheep scab from Wales.

Further details of the project will be announced in the forthcoming months following ongoing discussions with industry representatives.

Announcing the funding, the Minister said:

"Sheep scab has significant economic consequences for sheep producers and animal welfare issues for sheep. It is one of the most contagious disease of sheep in Wales and eradicating it is a priority for us and the industry. I'm pleased to be able to announce £5m Rural Development Programme funding will be used to help support the industry tackle the disease. Eradicating the disease has the potential to deliver significant lasting economic benefits for the sector at a particularly challenging time as we prepare to leave the European Union."

From 28/2/2019 we will no longer be able to email copies of Certificates and Schedules directly to RPW on your behalf as RPW will now only accept electronic documents that have been uploaded to them from your own businesses RPW account. We can continue to email electronic copies of your Certificate and Schedule to you directly if you require.



Get ready for Organic inspection:

Complete prior to audit:

- Complete annual inspection questionnaire
- Check that field schedule attached to inspection questionnaire is correct and amend if necessary

Make available for inspection:

- If any field number changes, please provide up to date map(s) of holding
- Field records including all inputs and outputs
- Manure management plan and completed Record Sheet 02
- Derogations applied for since the last inspection
- Habitat protection plan
- Purchase and sales records: receipts and invoices
- Labels – feed, seed, etc
- Up to date, complete feed records for all feeding groups (including grazing periods and forage fed)
- Medicine records – purchase and treatment
- Animal health plan
- Records – Movements, births and death
- Certificates for graziers and land rented
- Organic stock purchases – transfer documents and copies of certificates
